SUMMARY – An Ordinance to amend the boundaries of the area served by the Lower Kyle Canyon Citizens Advisory Council; and to change its name.

ORDINANCE NO. 5330

(of Clark County, Nevada)

AN ORDINANCE TO AMEND THE BOUNDARIES OF THE AREA SERVED BY THE LOWER KYLE CANYON CITIZENS ADVISORY COUNCIL; CHANGING THE NAME OF THE ADVISORY COUNCIL AND PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO.

WHEREAS, Clark County Code 3.32 provides for the establishment of Citizens Advisory Councils; and;

WHEREAS, the Lower Kyle Canyon Citizens Advisory Council was created by Clark County Ordinance No. 2449, passed March 21, 2000; and;

WHEREAS, the Lower Kyle Canyon Citizens Advisory Council boundaries were amended by Clark County Ordinance No. 2726, passed on March 5, 2002;

WHEREAS, part of the boundaries of the Lower Kyle Canyon Citizens Advisory Council was annexed to the City of Las Vegas on July 22, 2025, and the Council has need to amend its boundaries; and;

WHEREAS, because of the change of boundaries the Council is in need for a new name which more clearly and accurately describes the boundaries and jurisdiction of the Council;

NOW, THEREFORE, THE BOARD OF COUNTY COMMISSIONERS DOES HEREBY
ORDAIN AS FOLLOWS:

SECTION ONE. That the territory included in the Council's jurisdictional boundary, as outlined in Section 1 of Ordinance 2726, be amended to conform to the Map and Legal Description attached as Exhibit 1, as may be amended from time to time to exclude any territory annexed by the City of Las Vegas.

SECTION TWO. That the name given to the Lower Kyle Canyon Citizens Advisory Council, in Ordinance 2449, be amended to Upper and Lower Kyle Canyon Citizens Advisory Council.

SECTION THREE. If any section of this ordinance or portion thereof is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such holding shall not invalidate the remaining parts of this ordinance.

SECTION FOUR. All ordinances, parts of ordinances, chapters, sections, subsections, clauses, phrases or sentences contained in the Clark County Code in conflict herewith are hereby repealed.

SECTION FIVE. This ordinance shall take effect and be in force from and after its passage and the publication thereof by title only, together with the names of the County Commissioners voting for or against its passage, in a newspaper published in and having a general circulation in Clark County, Nevada, at least once a week for a period of two (2) weeks.




