SUMMARY - An ordinance to create a new Clark County Air Quality Regulation Section 108 to regulate volatile organic compound emission sources that may reasonably be anticipated to cause or contribute to elevated ozone levels within the 2015 ozone nonattainment boundary.

AN ORDINANCE TO CREATE A NEW CLARK COUNTY AIR QUALITY REGULATION SECTION 108, "VOC EMISSIONS CONTROL FOR PAPER, FILM, FOIL, FABRIC, OR VINYL COATING OPERATIONS," TO REGULATE SOURCES THAT MAY CAUSE OR CONTRIBUTE TO VOLATILE ORGANIC COMPOUND EMISSIONS WITHIN THE 2015 OZONE NONATTAINMENT BOUNDARY BY IMPLEMENTING EMISSIONS STANDARDS, WORK PRACTICES, PERMITTING OR REGISTRATION REQUIREMENTS, RECORDKEEPING AND REPORTING REQUIREMENTS; AND PROVIDING FOR OTHER MATTERS PROPERLY RELATED THERETO.

NOW, THEREFORE, THE CLARK COUNTY BOARD OF COUNTY COMMISSIONERS DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1. Clark County Air Quality Regulation Section 108, "VOC Emissions Control for Paper, Film, Foil, Fabric, or Vinyl Coating Operations," is hereby created as reflected in Exhibit 1, attached hereto.

SECTION 2. If any section of this ordinance, or portion thereof, is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such holding shall not invalidate the remaining parts of this ordinance.

SECTION 3. All ordinances, parts of ordinances, chapters, sections, subsections, clauses, phrases, or sentences contained in the Clark County Code in conflict herewith are hereby repealed.

SECTION 4. This ordinance shall take effect and be in force from and after its passage and the publication thereof by title only, together with the names of the County Commissioners voting for or against its passage, in a newspaper published in and having a general circulation in Clark County, Nevada, at least once a week for a period of two (2) weeks.

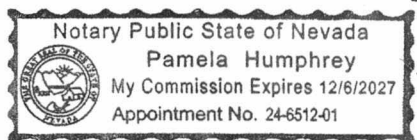
